Integra Realty Resources – Phoenix is pleased to submit the following Consulting/Research Services pertaining to Foothills Reserve. The intended use is to assist the HOA in establishing which property owners are entitled to condemnation proceeds (via settlement), and to assist the HOA and the court in establishing the amount of condemnation proceeds (via settlement) each resident is entitled to receive. The intended user(s) of the consulting assignment are: Foothills Reserve Master Owners' Association, Inc. Hereinafter, Foothills Reserve Master Owners' Association, Inc. are collectively referred to as the CLIENT, and IRR - Phoenix as CONSULTANT. The opinions and conclusions set forth in the report may not be understood properly without additional information in the Consultant's work file. Use of the report is restricted to the Client.

### **Prior Services and Reports**

IRR-Phoenix, LLC has previously performed appraisal and litigation support services for the Client regarding the properties identified in the condemnation proceedings in Civil Case No. CV2017-101359. In addition to the original Appraisal Report prepared on May 20, 2020 and a Surrebuttal Report prepared on June 4, 2021, revised opinions of just compensation were made and disclosed to the Arizona Department of Transportation ("ADOT") on December 14, 2021.

All of these opinions were based on an effective date of value of July 3, 2018, which coincided with the date of the Order for Immediate Possession. Each of these reports, as well as the IRR-Phoenix, LLC workfile, are necessary to understand the allocation of condemnation proceeds (via settlement) and therefore are incorporated in their entirety into this letter by reference.

### **Property Owners Entitled To Condemnation Proceeds (Via Settlement)**

As stated, the effective date of the value opinions provided in the Appraisal and Rebuttal Reports was July 3, 2018. I have been informed by legal counsel for the Client that this is also the day that generally establishes which property owners are entitled to condemnation proceeds (via settlement). While it is unknown if any property owners sold their home on or before this effective date and retained the rights to any condemnation proceeds, this analysis presumes that no such arrangements existed. It is well beyond the scope of this analysis to research the existence of such arrangements; as such, it is the responsibility of the Client and/or the specific property owner(s) to provide evidence to the Court that such arrangement exists.

For this analysis, I relied upon Monsoon, a tax records system maintained by the Arizona Regional Multiple Listing Service, in order to identify the property owners as of July 3, 2018. Monsoon contains all property records for the state of Arizona, regardless of whether or not they were listed on MLS. Unfortunately, neither the Maricopa County Assessor public records nor Monsoon can easily identify the names of the owners of the 589 single family homes as of a date other than a current date.

I was able to identify current ownership of each property as of January 26, 2022, and I was able to identify sale transactions between July 3, 2018 and January 26, 2022. Thus, I traced changes in ownership dating between January 26, 2022 and July 3, 2018 and was able to look back to the transfer deeds associated with each transaction to obtain the names of the sellers/previous owners as of July 3, 2018. In total, there were 162 sale transactions within Foothills Reserve between July 3, 2018 and January 26, 2022.

The ownership roll for all 589 properties is presented in the Addendum.

### **Allocation of Condemnation Proceeds (Via Settlement)**

As stated, IRR-Phoenix, LLC has previously performed appraisal and litigation support services for the Client regarding the properties identified in the condemnation proceedings in Civil Case No. CV2017-101359.

### **History of Proximity Damage Opinions**

The first set of opinions was modeled in a similar fashion as those offered by ADOT through their valuation expert, Gerald Zaddack. This was done for consistency purposes given the magnitude of properties involved in the condemnation proceedings. The analysis was based on a logical allocation of damages after determination of impact of the Loop 202 Freeway (the "Project") upon certain properties through visual observations on several occasions, personal interviews with various residents, and a review of numerous complaints filed with ADOT.

Information pertinent to the physical condition of the property was taken from physical inspections of the property on November 9, 2017, July 10, 2018, August 4, 2018 and March 16, 2020; an appraisal

prepared by Zaddack Valuation Advisors, Inc., dated January 10, 2020 with a date of value of July 3, 2018; and a review of aerial photography from the Maricopa County Assessor's Office GIS Mapping program.

I also reviewed various other documents including, but not limited to, the Noise Report for the South Mountain Transportation Corridor dated June 2014, the complaints filed in the United States District Court Case No. 2:15-CV-00893-DJH and 2:15-CV-0219-PHX-DJH, the March 2015 Record of Decision ("ROD"), the draft Environmental Impact Statement ("DEIS") of April 2013, the 2014 Final Environmental Impact Statement, the Final Noise Report (Pecos Segment) dated May 22, 2017, the right of way and relocation files for the 21 homes previously taken by the State of Arizona (ADOT), and documents produced by ADOT, including correspondence with property owners regarding the South Mountain Freeway.

Initially, it was my opinion that all of the homes within Foothills Reserve were damaged to some extent as a result of pre-condemnation blight (negative Project influence), and many homes were further damaged due to proximity to the Project (obnoxious noise, bright light from freeway lights, bright lights from vehicles/trucks, vibrations, noxious fumes, and visual blight).

This initial analysis did not fully take into account differences between one-story and two-story homes, and it relied heavily on the presentation of Full Cash Value from the ADOT appraisal and less on actual market transactions. Also, the Project was still under construction during the early phases of my analysis, having been completed and opened just prior to issuance of the Appraisal Report. Furthermore, the Covid-19 pandemic influence on travel and traffic in March, April and May 2020 just prior to issuance of the Appraisal Report severely hindered the ability to observe the full impact of the Project on the residences within Foothills Reserve.

By June 4, 2021, much more evidence became available for review, which altered and refined my opinion of damages; these new damage amounts were disclosed in the Surrebuttal Report mentioned earlier. By now, I was able to review 110 written complaints from residents within Foothills Reserve. I also made at least 2 more visits to the community to assess the impact of the Project, including in the evening after sunset. I also found and reviewed an article published in the Journal of the Acoustical Society of America, 2009, N.C. Ovenden, S.R. Shaffer, H.J.S. Fernando (2009) 126(1)25-35. This article, which reported on a study prepared for ADOT in March 2010, examined the impact of meteorological conditions on the propagation of vehicular noise from urban freeways. This article supported the contention that during certain times of the evening/early morning and during times of colder weather, noise levels in Foothills Reserve North can be elevated as well.

Furthermore, in response to allegations made by ADOT's appraisal expert regarding historical sales activity within Foothills Reserve, I researched initial sales (as newly built homes) and resales of homes within the Foothills Reserve community from inception to June 2021 for purposes of discovering paired sales (sale and resale) for value trend analysis. Paired data analysis is a quantitative technique used to identify and measure adjustments to the sale prices of comparable properties. To apply this technique, sales or data on nearly identical properties, or adjusted data, is compared to isolate and estimate a single characteristic's effect on value, in this case, changes in market conditions.

I also examined voluminous files produced by ADOT regarding the homes that they acquired in 2015 within Foothills Reserve. The values paid were fair market prices for these acquisitions. The ADOT acquisition prices should not have been influenced by the Freeway because they were acquired two years before this lawsuit was filed by ADOT and three years before ADOT took possession of the common areas.

Ultimately, this new evidence showed that, whether using the Maricopa County Assessor Full Cash Values or actual sales transactions, a comparison between these data sets provides a reliable method of estimating the Fair Market Value of the homes in the Before Condition, without the negative influence from the Freeway and the influence of the general loss in value of the homes caused by the Freeway. Moreover, the new evidence supported the opinions of proximity damages for the homes in Foothills Reserve South, but showed that reconsideration of the proximity damages for homes in both Foothills Reserve South and Foothills Reserve North was warranted, resulting in a reduction of proximity damages to many of the homes.

Just prior to my scheduled deposition in December 2021, I considered more refinements to the allocation of proximity damages based on the nature of the home being single story or two story. This refinement came about due to the increasing nature of complaints from owners of two story homes much more so than one story homeowners. My research of the actual sales activity within Foothills Reserve over time revealed that two story homes within Foothills Reserve South were negatively affected by the Project nearly twice as much as one story homes. Also, homes in Foothills Reserve North showed less negative influence on value on a percentage basis than one story homes in Foothills Reserve South; there was no noticeable difference in value changes between one story and two story homes in Foothills Reserve North.

This new evidence and analysis led to even further refined proximity damage opinions, and these opinions were provided to ADOT in advance of the deposition. The revised opinions shifted more proximity damages to two story homes in Foothills Reserve South and reduced proximity damages to all homes in Foothills Reserve North.

More specifically, many homes within Foothills Reserve South and North occupy locations that are negatively influenced to a greater degree than others. These homes and their additional proximity damages were identified in the original Appraisal Report, refined somewhat in the Surrebuttal Report, and refined slightly further in the pre-deposition analysis. In summary, homes that warranted additional consideration for specific location were those within roughly 400 feet of the freeway sound wall, those that lost the premium associated with being adjacent to the landscaped common area that was condemned and removed, and/or those having direct visual line-of-sight to the freeway or the freeway sound wall.

Shortly after the pre-deposition analysis was provided to ADOT, settlement discussions were held and a settlement was reached between the Client and ADOT.

### **Allocation Conclusion**

In summary, the formula applied in the pre-deposition proximity damages analysis is generally used as the basis for the allocation of condemnation proceeds (via settlement). As stated, this formula is the

result of nearly 5 years of analysis and revisions to the proximity damages opined in this condemnation case based on the ADOT expert reports, other expert reports, market evidence, and my own investigations and observations.

In general, all one-story homes in Foothills Reserve South are allocated a minimum of \$3,500 and all two-story homes are allocated a minimum of \$7,000. The lone exception to this minimum allocation pertains to Lot 73 Foothills Reserve Parcel D (2729 W Redwood Lane), which is the home of the Intervenor in Civil Case No. CV2017-101359 and is not eligible for a distribution of condemnation proceeds.

For Foothills Reserve North, all homes regardless of one-story or two-story construction are allocated a minimum of \$3,250.

In the Addendum are tables identifying the amount of net guaranteed settlement proceeds each property owner is entitled to. It is very important to note that the allocated amounts are based on a total distribution amount of \$4,500,000. This number is highly likely to change, particularly if certain legal proceedings (ADOT appeal) prove beneficial to the Client. It is my understanding that the \$4,500,000 utilized in this distribution is the minimum guaranteed amount (net of legal, court and other expenses) that the eligible homeowners will receive. Nevertheless, whatever the final amount becomes, the formulas and ratios established in this analysis will remain the same, so revising the allocation amounts will not be a complicated procedure.

In summary, eligible homeowners within Foothills Reserve North should receive \$822,250 in total proceeds (roughly 18.27% of the total amount) while eligible homeowners within Foothills Reserve South should receive \$3,677,750 in total proceeds (roughly 81.73% of the total amount).
